UNITED STATES' DETENTION REQUEST  
UPDATE / CLARIFICATION

15  
16 On July 7, 2023, the day after defendant was taken into custody, the government filed a motion  
17 for detention. ECF No. 6. This document serves to update the Court and amend / clarify two sentences  
18 from the original motion, which was prepared as agents were still executing search warrants.

19 As predicted, additional victims and witnesses have reached out to law enforcement since the  
20 defendant's arrest, and investigators are currently contacting and interviewing additional potential  
21 victims and witnesses. Two newly-confirmed victims (whose names have been redacted from this  
22 public filing, in light of 18 U.S.C. §§ 3771(a)(8) and 3509(a)(2)(A) and (d)(3)) strongly oppose the  
23 defendant's pretrial release. One victim, contacted on July 11, 2023, wrote:

24  
25 My name is [], I am a [], and I am a victim of Bradley Reger. I heard about the initial  
26 arrest a few days after it happened and saw that there was a detention hearing  
27 scheduled. Having spent a major part of my young life around Bradley, and all of his  
28 extended family, I am extremely aware of the danger of releasing Bradley prior to the  
conclusion of this investigation. Bradley has formed a large international web of  
support over the years, people who have turned a blind eye, assisted him or been too  
stupid to see through his facade. Bradley has contacts in several foreign countries and  
all over the United States. Furthermore, some of the areas I was taken to during my

1 years with Bradley were barely on a map, only accessible during tide changes or in  
2 small unlabeled clinics hidden away in church offices. He is good at hiding and has  
3 had high standing (wrongfully) with local susanville law enforcement, emergency  
4 services, town leaders, religious heads, politicians and even the families of his victims.  
5 Bradley has several apparently succesful companies and bank accounts that can be  
6 accessed at any time and also has had access to weapons. Normally rules are expected  
7 to be followed during court proceedings, however, having personally seen the extreme  
8 level of deceit and manipulation coupled with his access to funds, travel, families and  
9 religious safe havens, I do not, nor will I ever believe Bradley Reger should be  
10 released before the end of this investigation. Bradley Reger is a textbook flight risk in  
11 a case like this. He is not the type of man that will stand and answer for his possible  
12 crimes, he is most assuredly a man that will hide behind his family, his community,  
13 his faith, and anything else he can find to avoid facing judgement. I would not feel  
14 safe for myself or my family or even Bradleys own family knowing that Bradley  
15 Reger was free during this process. I plead with the person making the decision to  
16 keep Bradley detained until the completion of this investigation.

17 Following an interview on July 11, 2023, a different newly-confirmed victim wrote:

18 I believe it is in the best interest of me and other individuals who have suffered abuse  
19 by Bradely E. Reger that he not be released on bail. I am afraid that if he is allowed to  
20 return to Susanville, he will be free to harass me and others. We live in a small town  
21 and if I were to encounter him in my day to day life, it would cause me undue distress.

22 Thank you for your consideration of the victims at this time.

25 The government amends the sentence on page 3 of ECF No. 6, lines 24-25 to read: "During the  
26 execution of the search warrant in the "clinic" inside defendant's commercial building on July 6, 2023,  
27 agents found a doppler ultrasound device, but that was not the doppler device defendant repeatedly used  
28 on a minor victim." This clarification arose after investigators contacted the victim whom defendant  
abused using the doppler on July 11 and sent a photograph of the doppler device found at the "clinic."

The government amends the sentence on page 7 of ECF No. 6, lines 21-23 to read: "During the  
search of defendant's commercial property, agents found a file drawer with photocopies of passports of  
many people, including one now-confirmed victim and other potential victims, as well as travel and  
immigration documents."
